Free Internet Program

- EDC is partnering with Comcast to provide 556 low-income households in Sonoma County with free internet at a speed of 100/20 mbps for a period of one year.
- On March 11th the Sonoma County Board of Supervisors approved the housing sites listed below as priority for the free internet program.
- We are coordinating with MidPen and Burbank on outreach, which began the week of May 13th.
- We are hosting events for Q&A and enrollment support at each priority site throughout May and June. The first event was held at Springs Village on May 19th.
- Devices:
 - o EDC aims to provide a device to each family with school aged children in priority sites (apx. 300 total)
 - EDC has a \$21,000 digital equity grant to contribute to device procurement and we are negotiating match/contribution from Comcast

Federal Funding Cut - NTIA Digital Equity Capacity Grant (CalDEP)

- The CalDEP grant program is part of a \$1.44 billion awarded to states and Tribes for digital equity planning; California was meant to receive \$70.2 million.
- Sonoma County was expected to receive about \$530,000. EDC intended to partner with the Rural County
 Representatives of California (RCRC) and use the funding to develop a digital equity plan, partner with the Library
 and pay for a Digital Literacy Librarian, train staff at community partners as Digital Navigators, distribute devices
 and subscription subsidies, and other digital equity activities.
- Unfortunately, the California Digital Equity Program (CalDEP) application process has been terminated by the U.S. Department of Commerce, effective May 9, 2025. All activities related to this opportunity are on pause indefinitely.

Broadband Equity Access and Deployment (BEAD) Program

- BEAD is a \$42.45 billion program to expand broadband; California's allocation is approximately \$1.86 billion.
- EDC allocated \$1.2 million of our Broadband ARPA allocation to low-level/shovel ready engineering design to support BEAD projects.
- EDC ran a solicitation for "BEAD Local Match Assistance" to identify qualified Internet Service Providers or Non-Profits for EDC support of broadband services deployment projects throughout unserved and underserved areas of the county, especially those in rural and unincorporated communities where need for connectivity is high. The winning bidder(s) would receive support of up to \$2.3 million in low-level/shovel ready engineering design for their BEAD project area, which could also be used as the required local match for their application.
- The winning bidder was Etheric Networks, who proposed to serve the West Sonoma Valley/Glen Ellen area with a fiber-to-premises network, including 997 unserved/underserved locations and up to 20 miles of Middle Mile backbone into the Sonoma Valley.
- The Sonoma County Board of Supervisors provided a letter of support and commitment of up to \$1.2 million of matching funds to Etheric's application, which was submitted to the CPUC on May 9th. We expect the CPUC to make recommended awards late summer or early fall.
